- On page 13 of the Dutch form / page 12 of the English form it says:

"U geeft een overzicht van uw Beleidstheorie én een uitwerking van de activiteiten in het programma voor het eerste jaar van maximaal 3000 woorden". / "Notes to criteria P1 onto P14: In 3,000 words or less, give an overview of your theory of change and details of the activities to be carried out in the first programme year".

Is it correct that we can use a maximum of 3000 words for the combined ToC and first year of the programme activities? Or can we use 3000 words for the ToC; and another 3000 words for the first year programme activities?

 What is the maximum amount of words that can be used for the Track Record cases? I could not find this in the format.

On page 23 of the Dutch application form / page 20 of the English format its says that we need to add the following appendices: "1.12 Theory/theories of change; 1.13 Detailed programme proposal for the first year; 1.14 a track record in the form of three to five case descriptions.

5. Why do these documents need to be annexed again, as they are
