MEMORANDUM OF UNDERSTANDING

On Participation in the North European Gas Pipeline

Between the Ministry of Industry and Energy of the Russian Federation and

the Ministry of Economic Affairs of the Netherlands

The Ministry of Industry and Energy of the Russian Federation and the Ministry of Economic Affairs of the Netherlands, hereinafter referred to as the "Signatories",

whereas both countries are maintaining good energy relations which are part of the broader Joint Action Programme between the Russian Federation and The Netherlands for the period 2006-2007,

whereas a Memorandum of Understanding on cooperation in the area of energy efficiency and renewable energy sources was signed between the Ministry of Industry and Energy of the Russian Federation and the Ministry of Economic Affairs of the Netherlands on 21 April 2006 in Moscow,

whereas both countries have an interest in the construction of the North European Gas Pipeline (hereinafter referred to as "NEGP") as a vital link between the Russian gas fields and the consumers in Western Europe,

whereas close cooperation of both countries and their companies is key in the realisation of the potential of the NEGP for the future gas supply to Europe,

Have come to the following understanding:

Paragraph 1 Objectives and areas of cooperation

The Signatories will cooperate to ensure future gas flows from the Russian Federation to and through the Netherlands on sound economic conditions. This cooperation is an extension of their cooperation to energy efficiency and exchange of knowledge and expertise in this area with a view to ensuring efficient, reliable and clean supply and use of gas in both countries. The Signatories will cooperate to facilitate individual commercial negotiations between Dutch and Russia based companies on:

- potential mutual participation in large infrastructure projects as the NEGP and the Balgzand Bacton Line (herein referred to as the "BBL");
- transport arrangements for Russian gas through the Netherlands and potentially the BBL as fixed per long term transport contracts;
- arrangements for a Russian company to create flexible gas profile for Dutch customers in existing storages as fixed per storage capacity contracts or in new Dutch Russian co-developed seasonal storages;
- Gas purchasing arrangements between Dutch based and Russian based companies;
- Exchange of knowledge and information necessary for efficient, reliable and clean operation of facilities mentioned.

The Signatories contemplate that the Commercial Partners as mentioned in Paragraph 3, will conclude agreements concerning the areas of cooperation mentioned in this Paragraph.

Paragraph 2 Forms of Cooperation

Pursuing the aforementioned objectives will require cooperation and bilateral commercial negotiations of the Commercial Partners involved. The Signatories will facilitate these negotiations as follows:

- creation of a good political climate, also through this Memorandum of Understanding (this "MoU");
- in addition to the Commercial Partners identified in Paragraph 3, making an inventory of other commercial Netherlands based companies who may be future potential (end) customers of Russian gas;
- establishing good contacts between the Commercial Partners and these other companies;
- fostering that the Commercial Partners and any other companies involved in the implementation of this MoU will negotiate in good faith and aim at reaching an agreement, contributing to the objectives of this MoU;
- monitoring the progress of the different bilateral negotiations between such Commercial Partners and other companies; and
- contributing to the realisation of the objectives of this MoU by any other appropriate and legitimate means.

The Signatories and the Commercial Partners will take into account that the facilitations mentioned in and the agreements following from this MoU will take place in compliance with the governing legal frameworks.

Paragraph 3 Commercial Partners

In the context of this MoU the following commercial partners (herein referred to as "Commercial Partners") are involved:

Paragraph 4 Negotiations between Commercial Partners

The negotiations between the Commercial Partners will regard the following:

- gas transportation contracts between and for the transportation of natural gas in and through the Netherlands in compliance with the Dutch law, regulation and procedures;

- potentially a participation of in the BBL with a of and transport capacity in the BBL;

The Netherlands' government will contact other potential Commercial Partners based or operating in the Netherlands who may wish to purchase Russian gas volume. Agreements may be negotiated directly between and such potential other Commercial Partners.

Any agreement between ____ and any of the other Commercial

Partners ____ will be subject to contract and

management approval of the Commercial Partners involved.

Paragraph 5 Information/Confidentiality

The Signatories acknowledge that they will furnish each other with information which they believe to be reliable and relevant for the purpose of this MoU, but each Signatory also acknowledges that neither the other Signatory nor any of its representatives or employees make any representation or warranty as to the accuracy or completeness of such information.

Each Signatory will treat and will require each Commercial Partner based in its country and involved in the implementation of this MoU to treat the contents of this MoU as confidential. Information that is acquired by a Commercial Partner in the course of joint activities pursuant to this MoU may be used by such Commercial Partner's shareholders and executive organisation to support and approve any steps taken pursuant to this MoU. It is understood that each Commercial Partner will enter into a separate confidentiality agreement with its commercial counterparty regarding the subject matter of the negotiations contemplated by this MoU.

Paragraph 6 Communication

Any official communication between the Signatories and between Commercial Partners and Signatories under this MoU shall be to the following addresses:

Paragraph 7 Costs

Each Signatory and Commercial Partner will bear its own costs related to the activities, negotiations, agreements and contracts mentioned in this MoU and subsequently all costs related to the implementation of such agreements and contracts.

Paragraph 8 Dispute Resolution

The Signatories have consented that in the event of any dispute between the Commercial Partners in relation to or arising from the implementation of this MoU, the Signatories will encourage the Commercial Partners to use all reasonable endeavours to resolve such dispute amicably.

Paragraph 9 Discontinuation

This MoU will continue for an indefinite period provided that this MoU may be terminated by either Signatory giving thirty (30) days' written notice to the other Signatory and the Commercial Partners. This MoU represents the good faith intentions of the Signatories to proceed with the proposed cooperation.

The Signatories accept that if during the term of this MoU a Commercial Partner decides that it cannot proceed with the cooperation as envisaged at the time of the signing of this MoU, such Commercial Partner may terminate its participation under the umbrella of this MoU by giving not less than thirty (30) days' written notice of such termination to the Signatories and the other Commercial Partners.
