Allowance for Top Syndicates for Knowledge Innovation (TKIs)


The TKI is a partnership between public entities and private parties or investors. Cash grants of 40% are available on the private investment costs for the first €20,000 and 25% for the excess. In order to receive TKI allowances, the cash grant has to be invested in the R&D project of the partnership.

Innovation Credit

Innovation Credit is a risk-bearing loan from the government, intended for the development phase of a technically new product, process or service, including development of medical products that require a clinical study. Funding may vary from 25% (large companies) to 45% (SMEs) of relevant project costs with a maximum of €10 million, and the remainder being financed by the company's own resources.

Financial Risk Factor

The risk factor in the financial system (new financial instruments, non-performing loans, transparency) is adequately addressed.






Global Innovation Index 2015 – Top 10






Quality of roads - Chart




This chart shows **Railroad infrastructure development** across the 7 locations, expressed as Rating from 1 to 7.










Number of international destinations served from airports - Chart


Number of Top 100 Ports by total cargo volume - Chart


















The chart below shows total unit costs for job title: Junior Warehouse Operative for each location, broken down by salary and additonal costs


The chart below shows total unit costs for job title: Warehouse and Distribution Operative for each location, broken down by salary and additonal costs


The chart below shows total unit costs for job title: Warehouse Supervisor for each location, broken down by salary and additonal costs


The chart below shows total unit costs for job title: Head of Logistics for each location, broken down by salary and additonal costs


The chart shows the unit costs for Industrial space across each location.




The chart shows the unit costs for Office space across each location.






Traffic deaths per million habitants (2015)
































